****II. Approval of Minutes****

****III. Reports****

A. Office of Advancement Report- Updates from Caitlin Elder and Theresa Woehle.

i. Sausage Fest Update- It was mentioned that there should be no information released regarding Fest revenue until total expenses and income can be reconciled. The SF committee will release an official report of the outcome of the event in November.

ii. Golf Tournament- Scheduled Date is on May 29th, 2026.

iii. Auction- Scheduled date is on April 25th, 2026- Once Sausage Fest Party is finished, auction meetings will be planned.

iv. Playground Fundraisers- Planned to have a separate fundraiser for the playground in addition to the Auction's Raise the Paddle.

v. Alumni Event- Event was held in June 2025 and planned to organize another Alumni event again in Summer (June or July) of 2026.

B. Principal's Report- by Kris Peugh

- a. Enrollment Update- Student enrollment is around 400 students this SY2025-2026, and had a stable rate of enrollment compared to last year's data. A new procedure has been implemented in the admission of students. All applicants wishing to enroll from other schools must submit test scores, report cards and letters of recommendation for review prior to acceptance. Kris explained that CKCS requires the following from all students enrolled at CK.
 - 1. Everybody has to be safe
 - 2. The teacher has to be allowed to teach
 - 3. The students have to be allowed to learn
- b. Safety Update-
 - 1. Installed smoke and heat detectors throughout the school last spring and summer.
 - 2. An Annunciator Panel has been installed to identify the location of an activated fire pull station, allowing quick assessment of the source of a potential threat. Additionally, many doors have been equipped with magnetic locks designed to automatically close and secure during a lockdown to prevent intruders from accessing areas where students are present.
 - 3. Benton County Sheriff Dept. gave a great presentation on Safety for all school staff during the August inservice.
 - 4. First Emergency Drill (evacuation) was conducted on September 25th, 2025.
 - 5. Firearm Safety was conducted on October 23d, 2025 at 6:00 pm.
